NONCASH CONTRIBUTIONS

A Taxpayer's Guide

The IRS allows you to deduct the fair market value (FMV) of items donated to charity. The fair market value is the price a typical buyer would pay for an item of the same age, style, and use. Usually items are worth far less than you paid for them. Used items must be in good or better condition, and items of minimal value such as socks and underwear will be disallowed. It is wise to document your gifts with photographs and keep detailed information on the items given. Use the price ranges below to select a value indicative of the price you paid for the item and its condition. Price range maximum is for higher-end goods in excellent condition. When in doubt, use 20% of the purchase price.
